### CONCEPT NOTE

A strong civic space is instrumental to strengthen the resilience of democracies. As recognised in the 2022 Annual report on the application of the EU Charter of Fundamental Rights<sup>1</sup>, civil society organisations and human rights defenders play a key role in protecting and promoting the EU values of fundamental rights, rule of law and democracy. They are crucial in the system of checks and balances as they act as watchdogs, drawing attention to threats to the rule of law, democracy and the conduct of free and fair elections, thereby contributing to making those in power accountable. They contribute to overcoming challenges our democracies are facing, including by combating disinformation.

Independent civil society organisations also play a role in channelling the voices of the underrepresented in ensuring that all groups can express their opinions and advocate for their interests, and empowering individuals to participate in matters of public interest by creating opportunities for meaningful public participation. Channels for the participation of civil society organisations exist in many Member States, under various forms: permanent and ad hoc consultation mechanisms, and economic and social councils (for civil and social dialogue). They complement the increasing use of citizens' panels and other deliberative democracy tools.

However, in the consultation conducted in support of the 2022 Charter report, more than half of the participating organisations (53%) reported obstacles in 'participation and cooperation with authorities'<sup>2</sup>. The biggest challenges in this area were obstacles restricting their access to consultations and participation in decision-making (45%), as well as access to information and documents (42%). A significant number of organisations (30%) had encountered obstacles to civil dialogue more generally. According to FRA's findings, minorities and vulnerable groups are furthermore insufficiently represented in consultations<sup>3</sup>.

This seminar will discuss how civil society actors can further be empowered at the EU level in a meaningful way. It is organised in collaboration with the European Economic and Social Committee (EESC), as the second in a series of three targeted seminars on maintaining an open civic space in the EU (the first seminar took place on 10 May 2023 and focused on protecting civil society actors and the third is foreseen for 19 June 2023).

Among the participants will be representatives from the Member States, CSOs and human rights defenders, international organisations, Commission representatives, and EESC Members.
